Moving On

Decisions about transitions for young care experienced people who move onto independent living or need to return to a caring environment, will be made based on individual need. Housing pathways for care experienced young people will include a range of affordable options that are specifically tailored to their needs and preferences. Youth homelessness experienced by young care experienced people will be eradicated and they will have no need for any emergency provision or for rough sleeping because options are available and planned.

There is strong support in place to help young people navigate their future learning and employment options. Scottish Government has in 2021/22 increased their resourcing to the Developing the Young Workforce. notably by increasing the number of DYW support workers in schools. In parallel, the SG has made a significant investment in its Young Person's Guarantee, with £45 million going to local employability services. The YPG guarantee aims to offer all young people aged 16-24 a job, progress to learning or training, an apprenticeship or a first role in volunteering. Much of the funding will be used locally to offer recruitment incentives to employers to provide opportunities for young people, aligned with the UK Government's Kickstart programme. COSLA officers are working closely with LA employability leads through SLAED on the implementation of YPG, and advising the SG on its evaluation of YPG and the No One Left Behind.

A continuing challenge for LG will be to ensure that the transition from school based support to mainstream employability services is effective and seamless for young care experience people.
