

Councillor Kelly Parry, COSLA's spokesperson for Community Wellbeing, said: "The pandemic continues to impact women's equality and safety disproportionately. By refreshing the Supplementary Guidance on VAWG we aim to ensure that it will continue to be relevant and helpful to support the strong leadership being demonstrated by local authorities to keep women and children safe."

Key updates include:

- Additional information on heightened risks to women, children and young people experiencing VAWG during lockdown and other social restrictions to inform strategic planning and response through the next months;
- How collaboratively working with specialist VAWG services now schools have re-opened can support the trauma and wellbeing needs of children and young people to be met;
- How undertaking a strategic needs assessment will support linked learning being embedded in wider recovery and renewal planning;
- Highlighting how women have been disproportionately affected by the pandemic and how the use of equality and human rights impact assessments tackle gender inequality, including prioritising a shift towards preventing
